



**Tariff 5 Filing Alert  
September 15, 2020**

The purpose of this alert is to provide you with advance notice of an upcoming tariff filing that may impact billing for interstate access services. This Tariff 5 Filing Alert is provided as a free service to NECA's members (and their authorized consultants) that subscribe to NECA's electronic Tariff 5 filing notices. It is designed to assist members in planning for providing customer notification (when required under the FCC's rules), training customer contact staff and implementing system changes.

**Description of proposed filing:**

Based on the FCC's recently released Public Notice<sup>1</sup>, the current Universal Service Contribution Factor of 26.5% is expected to increase to 27.1%. NECA will be increasing the Federal Universal Service Charge to 27.1% in a tariff revision to be filed on September 16, 2020. All companies listed in Section 17.7(A) of the tariff will need to implement this change in their systems.

For those companies using FUSC rate banding, the percentage associated with the MLB EUCL FUSC rate bands will change as shown below. Company specific rate band assignments for a number of companies will also change in this filing. To ensure compliance with the FCC's customer notification rules and accurate billing implementation, each company listed in Section 17.7(B) should review the filing on September 16<sup>th</sup> for its individual rate band assignment and associated MLB EUCL FUSC surcharge factor to determine its customer notification obligations and billing impacts.
